Remote ID

About a year ago, a law was passed that would require all RC aircraft to have Remote ID (RID) that would transmit information. Flying at the field will be exempt from this requirement. Race Day Quads (RDQ) sued the FAA to block this law. About a week ago it was announced that RDQ lost the lawsuit. The law does not take effect until the end of September next year for pilots. The part that may become a problem is that the law states that manufacturers may not sell aircraft that do not have RID after 16 September 2022. There is a small possibility that you may not be able to buy ARFs after that date. It is very likely that the date will be postponed because the FAA has not released the final requirement for the formatting of the signal being transmitted. Hopefully there will be more information coming soon.
